Please note: For the purposes of meeting the requirements of Government Code sections 54222(a)(1) and 54230.5(b)(1), the noticing local agency is required to document evidence the Notice of Availability was distributed to all the required entities (HCD, CalHFA Certified Housing Sponsors, and all Local Public Agencies). A screen shot of the outgoing email showing all required email addresses will suffice.

Local agencies are advised to send out their emails using the BCC line.
